

AEGIS AV CABINETS LIMITED WARRANTY

Our warranty reaffirms our commitment to providing our customers with quality products and outstanding service. Please read it before making a purchase.

LIMITED WARRANTY

Aegis AV Cabinets provides the original purchaser of Aegis AV Cabinets brand products with this Limited Warranty.* This warranty applies only under conditions of normal, indoor, residential or commercial use.



WARRANTY COVERAGE

Aegis AV Cabinets products are warranted to be free from defects in workmanship, materials, and construction for five (5) year from receipt in the home or business. Individual electronic components are subject to their manufacture warranty. All thermostats, switches, lighting, and home automation components come with a one (1) year warranty to be free from defect and will be replaced or repaired at the discretion of Aegis AV Cabinets. AC Infinity cooling products come with a two (2) year warranty to be free from defect and will be replaced or repaired at the discretion of Aegis AV Cabinets. Tripp Lite AC Surge protectors warrants, for the life of the product, (at Tripp Lite's option) to repair or replace (on a pro rata basis) directly connected equipment that is due to a power transients while properly connected to the Tripp Lite ISOBAR 12 ULTRA offering the Ultimate Lifetime Insurance Policy up to and not to exceed \$25,000. Panamax BlueBolt products carry a three (3) year warranty, and \$5 million insurance policy towards connected equipment to be repaired or replaced at Panamax's discretion.

WARRANTY LIMITATIONS AND EXCLUSIONS

This warranty does not apply to minor size, shape, and color variations from piece to piece that can occur due to craftsmanship and the use of natural materials in Aegis AV Cabinets products. This warranty does not apply to minor color variations between actual furniture pieces, and/or photographs (electronic or print). Wood furniture will have natural variation in grain and color, and inherent characteristics such as knots, mineral streaks, pitch pockets, and grain variation. These are not considered quality defects. This warranty does not apply to Aegis AV Cabinets products sold "as is" or purchased from a source other than Aegis AV Cabinets. Any product modification voids this warranty. Aegis AV Cabinets products are not warranted against normal wear and tear, damage resulting from improper use or installation, accidents, abuse, neglect, or damage or appearance changes resulting from improper care or storage. This warranty does not apply to damage or appearance changes related to the expansion and contraction of wood due to extremes in humidity. This warranty does not apply to any problems that arise from customer provided stains and paints when they have chosen the "Custom Paint" or "Custom Stain" option.

THE REMEDIES PROVIDED HERE ARE EXCLUSIVE AND TO THE EXTENT ALLOWED BY APPLICABLE LAW ARE IN LIEU OF ALL OTHER REMEDIES, WARRANTIES, OR REPRESENTATIONS, EXPRESS OR IMPLIED OR STATUTORY, INCLUDING, BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND ALL OTHER OBLIGATIONS AND LIABILITIES, WHETHER IN CONTRACT OR IN TORT, ALL OF WHICH ARE EXPRESSLY DISCLAIMED HERE. IN NO EVENT SHALL AEGIS AV CABINETS BE LIABLE FOR SPECIAL OR CONSEQUENTIAL OR OTHER DAMAGES.

This warranty is valid only in the continental United States, excluding Alaska and Hawaii and only on Aegis AV Cabinets and their factory installed components.

YOUR RIGHTS

This warranty gives you specific legal rights and you may also have other rights which vary from state to state. Some states do not allow the exclusions and limitations on incidental and consequential damages or the limitations on implied warranties, so the described limitations may not apply to you. However, proper care and use are essential for preserving your rights under this warranty.

WARRANTY SERVICE

Provide your dated sales receipt to initiate your warranty claim, and, if possible, proof of delivery date as well. The sole remedy provided by Aegis AV Cabinets under this warranty will be to repair or replace the defective part or product or to issue a refund of the price paid. Aegis AV Cabinets reserves the right to decide the appropriate remedy. If we decide to replace the defective item, only the defective item will be replaced. If we decide to replace a product we no longer sell, we will replace it with a comparable product. Refunds, if any, will be adjusted for the product's use and age.
